Terms of Reference

Acting on behalf of Academic Council:

- 1) To define and enhance the University College of Osteopathy's research innovation and culture.
- 2) To define and promote the University College's Research and Scholarship Strategy and operational plans.
- 3) To monitor progress towards implementing the University College's Research and Scholarship Strategy.
- 4) To develop and consider the implementation of new areas of research and enhancing scholarship.
- 5) To identify and plan resource allocation to enable delivery of the Research and Scholarship Strategy for consideration by Academic Council as part of the annual budgeting cycle.
- 6) To review and recommend to Academic Council new/significant changes to research degrees.
- 7) To monitor the research elements of research award bearing programmes.
- 8) To report annually to the Academic Council about the Committee's Activity, including action plans for the coming year.
- 9) To receive and consider the Annual Monitoring Reports of all research degrees.
- 10) To manage, keep under review (including efficiency and effectiveness) the University College's research ethics process on behalf of Academic Council.
- 11) To produce an Annual Research and Scholarship Report for the Academic Council.
- 12) To monitor adherence to the Research Integrity and Governance Policy.



13) To monitor Research and Scholarship Strategic Plans.
